

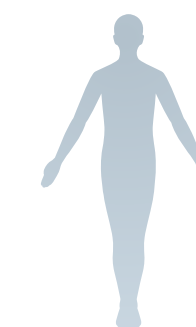

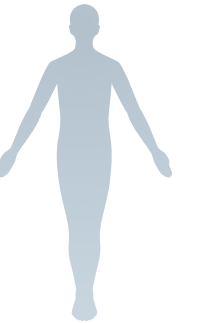


Founded in the United Kingdom in 1989, Alliance Medical has been present in Italy since 2004.

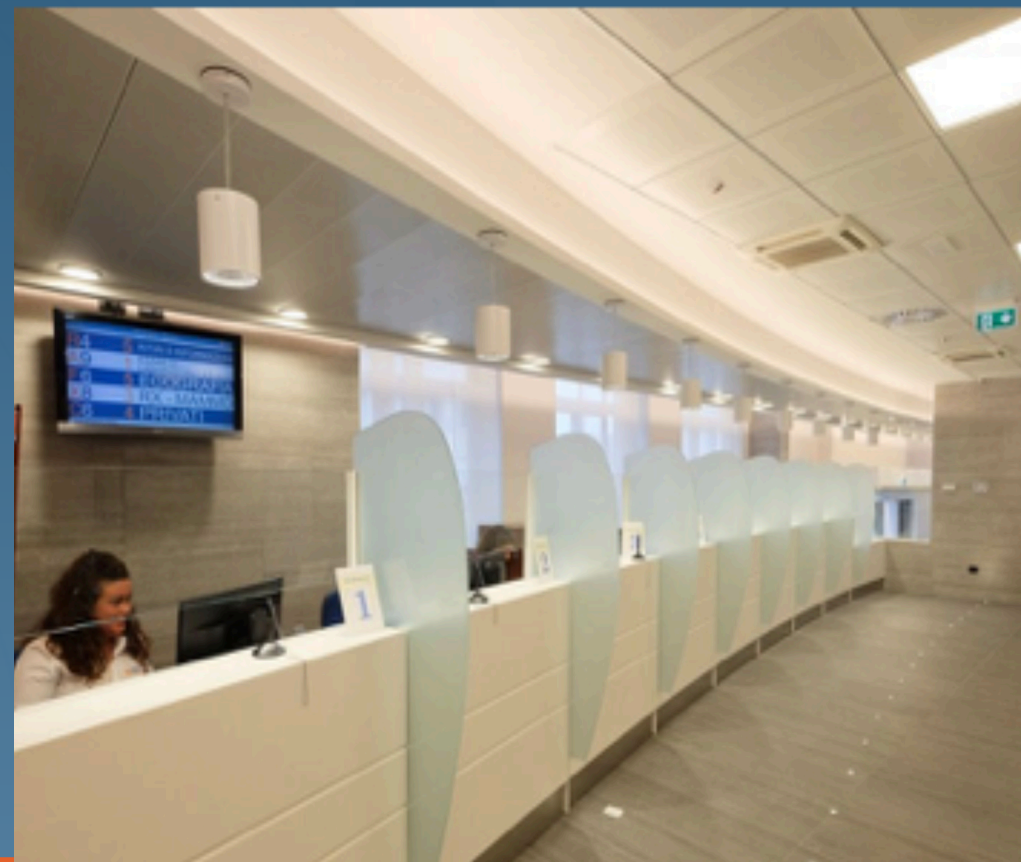
The Alliance Medical group was acquired in 2024 by the iCON Infrastructure fund.
